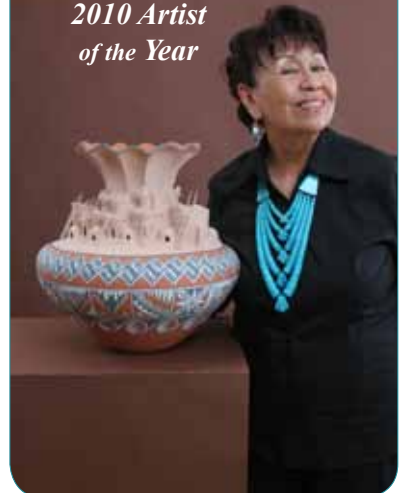
Badges must be worn at all times in the Exhibit Hall. Please designate "Guest" if the individual does not work for your company.

MEMBER BUYER'S PREVIEW

IACA Member Buyers (retail and wholesale members), in good standing with dues paid up-to-date, are eligible to attend the special *Member Buyer's Preview* on **Friday, October 22, 2010**, from 9:00 a.m. until 11:00 a.m., before the Market opens to other qualified buyers.

BUYER POLICIES

1. Everyone must register and wear a badge to enter the Exhibit Hall.
2. Buyers must provide proof of business: retail/resale license and a business card or brochure.
3. Children age 12 and under must be accompanied by an adult at all times.
4. No photos or other recordings are to be taken without permission of IACA and the exhibitor.
5. Smoking is only permitted in outside designated areas.
6. Animals are not allowed with the exception of service animals accompanying individuals with disabilities.
7. The IACA Market is a private event and IACA reserves the right to refuse entrance/service to anyone.

BADGE POLICIES FOR BUYERS, EXHIBITORS, MEMBERS & GUESTS

1. Persons designated as Buyers will be issued "Buyer" badges and may purchase from all Exhibitors for the trade.
2. IACA Member Buyers (Retail or Wholesale Members) will be issued "Member" badges with a "Buyer" designation in order to purchase for the trade.
3. IACA Collector, Sustaining, Honorary, and Museum Members will be issued "Member" badges and may purchase only from Artists/Craftspersons Exhibitors. Purchases are made at retail prices determined by the artist and appropriate sales taxes should be paid.
4. Persons designated as Guests will be issued "Guest" badges.
5. Exhibitors and their personnel are designated as Exhibitors and will be issued "Exhibitor" badges.

GUEST POLICIES

1. A Guest Badge will be given to Buyers who are not wholesale buyers.
2. Exhibitors and Buyers are responsible for their Guests.
3. Guests must be accompanied at all times by their host Exhibitor or Buyer.
4. Guests may not conduct business transactions and may not make purchases without IACA and Exhibitor approval.
